# Hands-On Fire suppression-100

## 101

### Targeted Search and Rescue

This will be a combination of classroom lecture, discussion, and hands-on training located at the BGF D Public Safety Training Center. The morning portion will consist of discussion and explanation of the determining factors and the decision-making processes leading to the use of targeted search. Also covered will be some basic ladder and access techniques; tool selection; and victim positioning and removal from first and second floor locations. The afternoon session will provide opportunities for hand-on application of the discussed principles and techniques in a simulated fire environment.

**PPE requirements: Full structural firefighting PPE and SCBA. Class size is limited. Students must be comfortable operating in Structural PPE and SCBA prior to the class and be able to perform difficult physical tasks while “on air”.**

### Basic-20 Firefighting Course

The course will include “hands-on drills and the opportunity for students to Don protective equipment.

## Helicopter & Vehicle Fire Props

This is a NFPA 1403 compliant LIVE-FIRE course which will utilize the Helicopter and Car Fire prop. This course will prepare the student for IFSAC Firefighter I and II testing by using all available props utilized during testing scenarios.

Equipment Needed: Full turnout gear and SCBA with PASS device and spare cylinder. **All turnout gear must be NFPA compliant with no component older than 10 years. Students will not be allowed to participate if the instructor(s) find that the gear is not NFPA compliant or otherwise poses a hazard. SCBA cylinders must have a current hydrostatic test date.**

Prerequisites: Completion of NFPA 1403 required components prior to enrolling;” Live Fire Course Competency Validation” form (pages 21-22) must be mailed in with payment. Any student with facial hair that impedes the seal of the face piece will not be allowed to participate in accordance with NFPA Standards.

## Fire Blast -Prop

This class will utilize the Kentucky Fire Commission’s new Fire blast Burn Trailer to provide the students with a variety of fireground situations. Included in the capabilities of the trailer will be firefighting a below grade fire, standpipe operations, pitched roof ventilation, second story firefighting, room and contents fire, search and rescue operations in a smoke-filled environment and other situations as time allows. Students enrolling in this class should come prepared to learn and work as a firefighting team. This class will benefit both new and experienced responders. This class will concentrate on hands-on “learning by doing” skills.

**PREREQUISITES: Live Fire Course Competency Validation form (or similar verification). Any student with facial hair that impedes the seal of the face piece will not be allowed to participate in accordance with 29 CFR 1910.134 (OSHA). Protective gear will be inspected prior to entry into the trailer. All gear must be within the 10-year from manufacture date. Required Equipment: In-date turnout gear and SCBA Live Fire Competency Validation Form**

**This class is limited to 25 students.**

**This class will be on Sunday only.**

### Smell, Bells, and More...

  - i. What are we carrying in our turnouts or on our rigs that can help with passive entry

This 24-hour course will also qualify as CEs for state recertification as an EMT-Basic. This course will provide you with the required hours needed to recertify for your current EMT license. This course will also include the 2-hour HIV/AIDS education requirement. Students should bring a CPR pocket mask, penlight, and stethoscope.

## Fire Inspector 1

This class is the Kentucky Fire Marshal's Fire Inspector I Certification program. fire and building code officials will benefit from this course. This class will provide instruction based on NFPA 1,2018 Fire Code, the Kentucky Standards of Safety (815 KAR 10:060) and the KBC Building Code. Officials will learn basic principles of a fire inspection program, and how it relates to the KBC and IBC. This class will consist of one day of instruction followed by an exam.

### Course Objective:

Prepare the attendees to conduct fire inspections of buildings and property for fire hazards and code compliance per 815 KAR 10:060 (The Kentucky Standards of Safety).

Determine, if necessary, fire protective equipment is operational, maintained and in compliance to the code.

Determine the adequacy of exits. Determine an occupant load for a facility. Where required, emergency fire evacuation drills are held. Advise property owners of the inspector's findings.

Gain an understanding of projects that must be approved by the Division of Building Code Enforcement and other Divisions within the Department of Housing, Building and Construction.
